



Earnings Flash Note Aamal Company 1Q 2024



Aamal Company (AHCS)

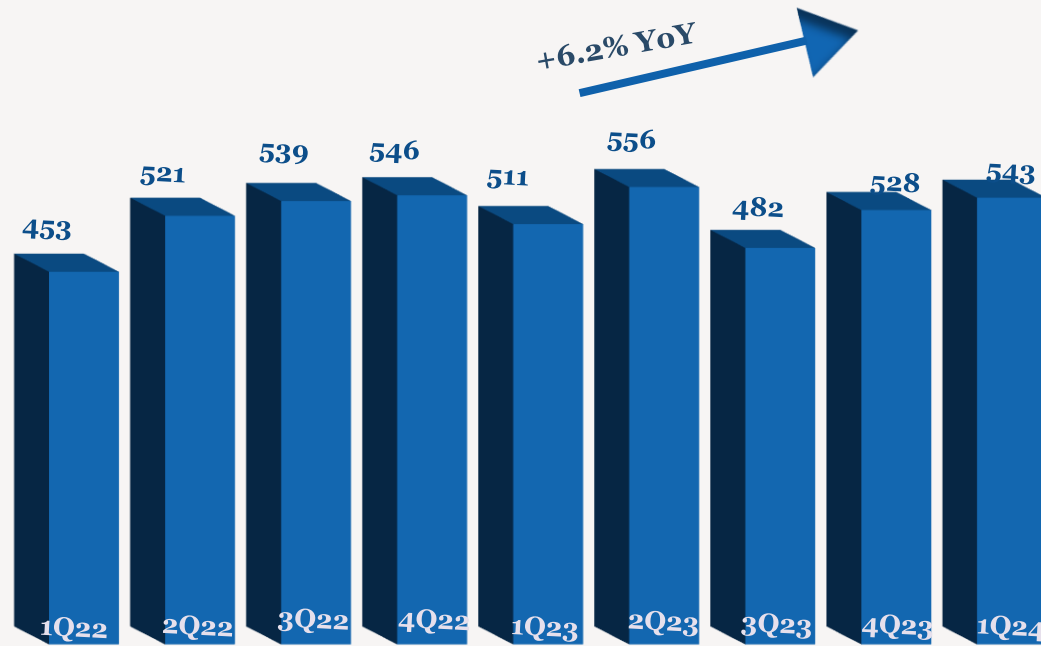
- > Net profit increased by 7.5% YoY (-7.9% QoQ) to QR94mn in 1Q2024 due to higher sales and lower net finance costs.
- > Total revenue came higher by 6.2% YoY (+2.9% QoQ) to QR 543mn in 1Q2024.
- > Gross profit rose by 8.4% YoY to QR130mn (-6.7% QoQ) while the corresponding margin came to 24.0% in 1Q2024 (vs. 23.5% in 1Q2023).
- > Operating profit of QR85mn was up by 5.3% YoY (-4.8% QoQ) and margin came to 15.6% in 1Q2024 (vs. 15.8% in 1Q2023).
- > For 1Q2024, EPS came to QR0.015 vs. QR0.014 in 1Q2023.
- > As of 28th April 2024, the stock has decreased 8.3% YTD, outperforming the QSE index, which was down by 10.7% YTD.
- > The stock is currently trading at a TTM P/E multiple of 13.0x.

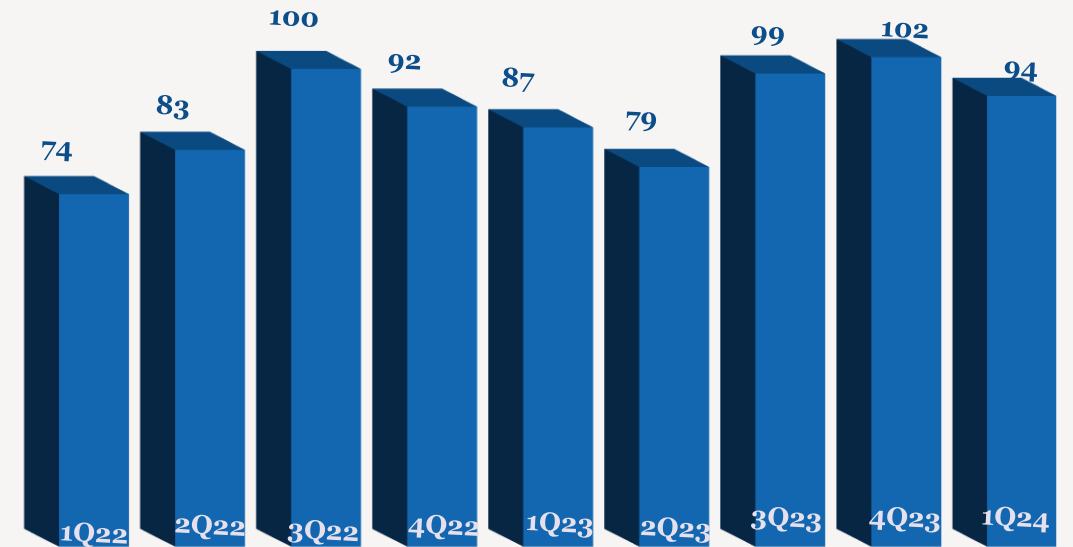

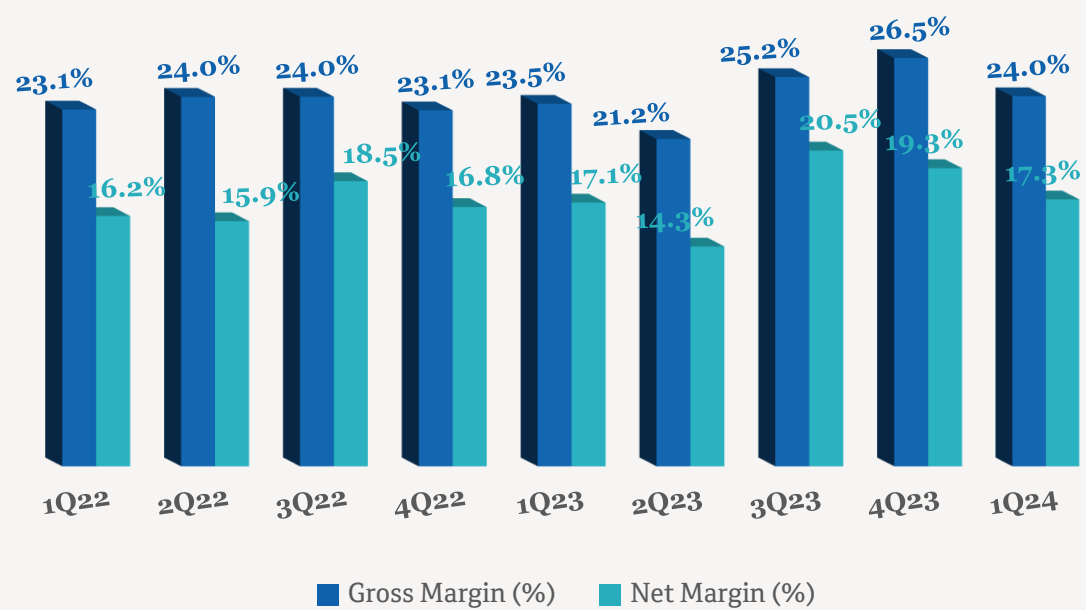
Quarterly Sales Trend (QRmn)



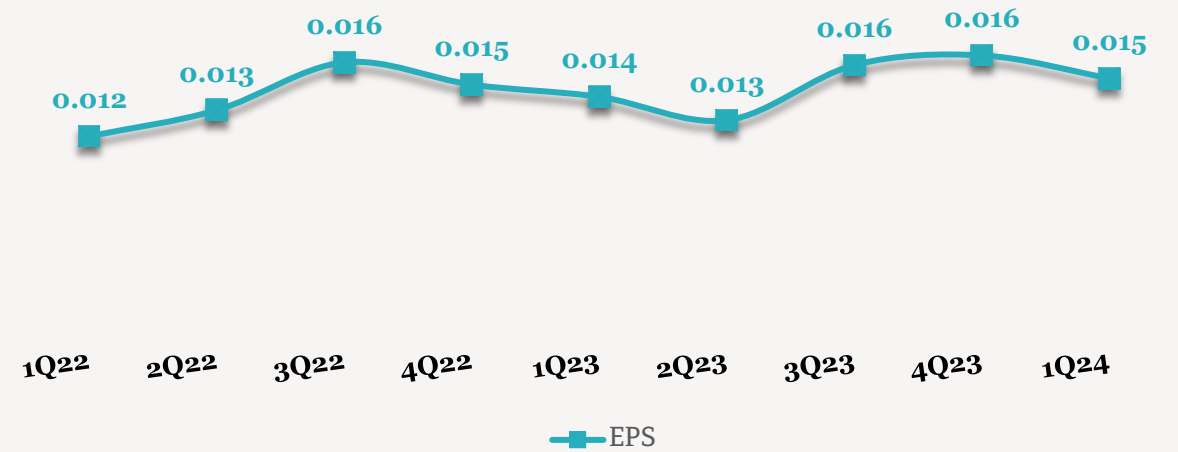
Quarterly Earnings Trend (QRmn)
