

Barwa Real Estate Company (BRES)

- > Net income increased by 0.6% YoY to QR319mn (+34.0% QoQ) in 2Q2024 primarily due to higher rental income. For 6M2024, net income was up 0.8% YoY to QR557mn.
- > Rental operating profit increased by 16.6% YoY (+1.8% QoQ) to QR292mn in 2Q2024. Meanwhile, rental operating margin declined by 1.0ppts YoY to 81.0% (-4.3ppts QoQ) in 2Q2024. For 6M2024, rental operating profit was down by 8.2% YoY to QR578mn
- > Operating profit was down 1.5% YoY (+15.7% QoQ) to QR478mn in 2Q2024 For 6M2024, operating profit came in at QR890mn (-4.0% YoY).
- > For 2Q2024, EPS was flat at QR0.082. For 6M2024, EPS was 0.143 vs 0.142 in 6M2023.


- > As of 29th July 2024, the stock has decreased 3.6% YTD, outperforming the QSE index, which was down by 6.1% YTD.
- > The stock is currently trading at a TTM P/E multiple of 8.8x.




Quarterly Revenue Trend (QRmn)




Quarterly Margin Trend
