

Dlala Brokerage and Investment Holding Co (DBIS)

- > For 1Q2025 the company reported net loss of QR1.7mn as compared to net loss of QR5.0mn in 1Q2024 and net loss of QR1.9mn in 4Q2024, due to higher net operating income.
- > Brokerage Commission Income decreased by 14.2% YoY (+4.6% QoQ) to QR3.3mn in 1Q2025.
- > Gross profit decreased by 5.8% YoY to QR1.9mn (+2.8% QoQ) while the corresponding margin rose by 5ppts YoY to 56.9% in 1Q2025.
- > For 1Q2025, Loss per share came at QR0.01 vs. Loss Per Share of QR0.03 in 1Q2024.


> **As of 23rd April 2025, the stock has decreased 10.2% YTD,** Underperforming the QSE Index, which was down by 3.2% YTD.


Quarterly Brokerage Commission Income Trend (QRmn)
