

Qatar Electricity and Water Company (QEWS)

- > Net profit decreased by 9.7% YoY to QR288mn (+26.6% QoQ) in 1Q2025 due to higher cost of sales and lower other income and interest income.
- > Total revenue came at QR681mn (-0.9% YoY/-7.1% QoQ) in 1Q2025.
- > Gross profit decreased by 7.2% YoY to QR209mn (-25.1% QoQ) and the margin came at 30.6% (vs 32.7% in 1Q2024) in 1Q2025.
- > For 1Q2025, EPS came at QR0.26 vs. QR0.29 in 1Q2024.
- > As of 20th April 2025, the stock has decreased 5.0% YTD, Underperforming the QSE Index, which was down by 4.1% YTD.


> The stock is currently trading at a TTM P/E multiple of 11.8x. For now, we maintain our PT of QR 20.0/share and Accumulate rating.


Quarterly Sales Trend (QRmn)




Quarterly Margin Trend
