

Qatar Fuel (QFLS)

- > Net profit fell by 5.3% YoY to QR230mn (-18.0% QoQ) in 1Q2025 primarily due to lower revenue and other income.
- > Revenue decreased by 7.4% YoY to QR6,323mn (-6.0% QoQ) in 1Q2025.
- > Gross profit rose 3.6% YoY to QR193mn (+24.7% QoQ) and the corresponding margin came at 3.0% (+0.3ppts YoY; +0.8ppts QoQ) in 1Q2025.
- > Operating profit was up 9.8% YoY to QR115mn (+12.7% QoQ) and the corresponding margin came at 1.8% (+0.3ppts YoY. +0.3ppts QoQ) in 1Q2025.
- > For 1Q2025, EPS came at QR0.23 vs. QR0.24 in 1Q2024.


- > **As of 22nd April 2025, the stock was flat YTD,** outperforming the QSE Index, which was down by 4.1% YTD.
- > The stock is currently trading at a TTM P/E multiple of 14.3x, lower than its 3Y historical average of 15.9x. For now, we maintain our PT of QR 18.59/share and Accumulate rating.




Quarterly Sales Trend (QRmn)
