

Qatar General Insurance & Reinsurance Co. (QGRI)

- > Net Profit came to QR31mn in 2Q2024 (+71.0% YoY) as compared to loss of QR10mn in 2Q2023. For 6M2024, net profit was up 38.8% YoY to QR49mn.
- > Insurance revenue increased by 15.1% YoY (+15.3% QoQ) to QR235mn in 2Q2024. For 6M2024, insurance revenue was up 11.2% YoY to QR439mn.
- > Investment and other operations income was QR51mn (vs QR13mn in 2Q2023). For 6M2024, investment and other operations income was up 93.1% YoY to QR80mn.
- > For 2Q2024, EPS was 0.035 vs loss per share of 0.011 in 2Q2023 For 6M2024, EPS was 0.056 vs 0.040 in 6M2023.


> As of 31st July 2024, the stock has decreased 37.8% YTD, underperforming the QSE index, which was down by 6.2% YTD.




Quarterly Insurance Revenue (QRmn)




Quarterly Investment and Other Operations Results (QRmn)
