

QLM Life & Medical Insurance Co. (QLMI)

- > Net profit decreased by 12.8% YoY to QR15mn in 1Q2025 (+49.3%QoQ) on account of lower insurance service result.
- > Insurance revenue rose by 7.2% YoY to QR299mn (-13.9% QoQ) in 1Q2025.
- > Total income fell 9.3% YoY to QR20mn (+26.7% QoQ) in 1Q2025.
- > For 1Q2025, EPS came to QR0.04 vs. QR0.05 in 1Q2024.
- > As of 29th April 2025, the stock has decreased 4.1% YTD, Underperforming the

QSE Index, which was down by 2.3% YTD.


> The stock is currently trading at a TTM P/E multiple of 10.8x. For now, we maintain our PT of QR 2.37/share and our Accumulate rating.




Quarterly Revenue Trend (QRmn)
