

# Qatar Oman Investment Company (QOIS)

- > Net profit came to QR3.7mn (vs. Net profit of QR0.6mn in 1Q2024) in 1Q2025 as against the net loss of QR56.9mn in 4Q2024 primarily due to higher investments and interest income.
- > Rental income from investment property decreased by 2.9% YoY (+6.6% QoQ) to QR0.5mn in 1Q2025.
- > Investment and interest income came at QR4.2mn (vs. Net loss of QR0.4mn in 4Q2024) in 1Q2025 as against the income of QR1.2mn in 1Q2024.
- > For 1Q2025, Earnings Per Share came at QR0.012 vs. QR0.002 in 1Q2024.


> **As of 30th April 2025, the stock decreased 6.1% YTD, Underperforming** the QSE Index, which was down by 1.1% YTD.




# Quarterly Investment and Interest Income Trend (QRmn)




### Quarterly Total Income Trend (QRmn)
